Chair Baker-Baumann called the retreat to order at 9:00 AM.

1. <u>Discussion with the President</u> – Chris Spradlin, President

President Spradlin gave the Trustees an overview of how he sees Edison State in the present, how it has changed and evolved over the years, and where the College will be in the future. He presented on the College's bright future, challenges, and opportunities.

President Spradlin also went over items including policy governance, the most recent employee satisfaction survey results, and his presidential goals for AY 2023-2024.

A. Policy Governance

 President Spradlin went over the Carver Guide: Basic Principles of Policy Governance by John Carver and Miriam Mayhew Carver, as well as the College's strategy map.

B. Employee Satisfaction Survey Results

- President Spradlin went over the summary of results of the annual employee satisfaction survey with the Trustees and relayed how he will address any concerns that were garnered from the results.
- C. President's Goals for Academic Year 2024-2025
 - President Spradlin relayed his goals for AY 2024-2025 with the Trustees.
 - His goals center around items such as external relations, staff, faculty, and student listening sessions, completing his doctoral degree, and meeting one-onone with each Trustee.

2. <u>Open Meetings Act and Ethics Training</u> – Mia Yaniko, Education Section Chief, Office of the Ohio Attorney General

Ms. Yaniko gave the Trustees their annual ethics training for the state of Ohio. Ms. Yaniko discussed such topics as conflict of interest, public contracts and nepotism, gifts and things of value, confidentiality, and post-term restrictions. Ms. Yankico also went over Ohio Sunshine Laws and the Open Meeting Act, Ohio Revised Code Section 121.22.

The Trustees had the opportunity to ask Ms. Yaniko questions.
